### 主席寄语

### President's Foreword

全位会员,大家好!又到了向大家报告一年工作的时候了。总的来讲,2014年随着外部环境的持续改善,协会各方面工作都稳中有进,会员数量不断攀升,许可金额显著增长,版税分配全部完成。

在此,我很高兴能够继续向大家报喜:2014年协 会全年许可收入达到 1.37 亿元人民币, 较上一年增长 22.36%, 再次创出新高。更可喜的是, 这一增长主要 来自曾经困扰协会相当一段时间的信息网络传播权业 务(亦称新媒体业务)。还记得2011年协会与百度公 司合作, 共同开拓出中国网络音乐作品正版化的主渠 道模式吗?经过几年的辛勤耕耘,这一主渠道也在不 断扩大,正帮助千千万万个音乐创作者实现更大权益, 帮助众多互联网商家走上正版之路……2014年协会与 中国移动、中国联通、腾讯公司等的著作权合作使得 此项业务再次有了明显扩升,已可以与表演权、广播 权业务共同成为支撑协会许可工作的主要支柱,相信 未来可以为各位会员带来更多收益。这不仅说明协会 的许可结构进一步趋向合理化,由此为广大会员维权 的能力也得到了大幅提升,而且不断以实践证明着: 在数字环境下,协会依然可以在服务音乐创作者、共 创和谐产业关系上发挥极其重要的作用。

交流、合作、共赢,这是协会一贯的工作导向。

2014年,协会在其他各方面的合作也有很多,择要如下: 一是与南京青年奥运会组委会达成协议,为 2014年南京青年奥运会提供音乐著作权许可与服务;二是深入中央音乐学院等院校,为专业音乐创作者免费开展音乐著作权讲座,并且提供便捷的入会服务;三是国际作者和作曲者协会联合会(CISAC)亚太区委员会于年初从新加坡迁至北京,协会今后可以更方便地与国际组织、其他海外协会建立更密切的联系与合作。

团结、斗争、团结,这是协会促使更多音乐使用企业、行业合法使用音乐的必由之路。正因如此,2014年协会继续加大了音乐著作权维权的范围和力度,并开启了中国大陆广播权诉讼维权的元年。对协会来讲,通过诉讼方式维权实是无奈之举,但也是巩固和深化广播权许可工作的必然。2012 至 2013 年期间,经过多轮谈判,协会与中国广播电视协会下属电视、广播两个版权委员会分别达成一致,形成了广播行业音乐作品著作权付酬解决方案。此后,全部中央级、大部分省级、部分重点市级的电台及电视台先后与协会签署了付酬协议。对于那些仍然无视相关法律法规和行业解决方案的广播组织,协会唯有借助司法诉讼等法律手段,这既是为了维权,也是为了维护著作权市场的公平有序。

协会 20 余年的工作实践证明,音乐作品著作权集体管理的效果如何,不仅依赖于协会自身的坚持与投入,也取决于外部环境的改善程度,具体讲包括全社会的版权法律意识、对版权的立法保障、对侵权行为的司法判赔力度等等。协会希望可以通过诉讼维权的方式,尽快地让"尊重音乐创作者的智慧劳动"不再是一句口号,而是清晰的法律意识和明确的实际行动。

2015年协会又将迎来换届之年,我们相信协会的未来之路会随着国家大势越走越广阔。即使前路依然充满荆棘和不平,协会也一定会在新一届领导班子的带领下,努力面对,同心度过难关。协会是"铁打的营盘流水的兵",不论老兵还是新兵,一定要牢记我们的职责:为音乐创作者站好岗,坚守住我们共同的版权家园。

Dear members! It is the time for MCSC Annual Repot again. In general, under the continual improvement of the outside environment, all of MCSC's work grew steadily in 2014 with the increasing of membership and of licensing revenue and the full completion of royalty distributions.

Here It is with great pleasure that I introduce to you the achievements MCSC made in 2014: The total licensing revenue hit another high to reach 137 million Yuan RMB, at a rise of 22.36 % compared to the year of 2013, in which the main growth came from the business of new media licensing (information network licensing). Remember that MCSC and Baidu pledged to work together to build a legitimate channel for digital music usage in Chinese market in 2011? After years of efforts, this legitimate channel has been expanding constantly to urge a multitude of internet service providers for their legal usage of music and help millions of music creators gain more and more profits. In 2014, MCSC's cooperative business with China Mobile, China Unicom, Tencent and so on further made its new media licensing promoting remarkably, which at present has become the main business as important as MCSC's performance licensing and broadcasting licensing. We believe that our collection from new media licensing will bring more and more benefits for our members in future. So far, not only MCSC's licensing framework has been further rationalized to make itself a higher level of competence in copyright protection for its members, but also it has proved that MCSC can still play an vital role in creating a harmonious relationship between music creators and industries.

Communication, cooperation and mutual benefit constitute the consistent work orientation of MCSC. By 2014, cooperation with many other sectors has been reached. For example, MCSC signed an agreement with the Nanjing 2014 Youth Olympic Games Organizing Committee (NYOGOC) for the purpose of protecting copyright of musical works worldwide during the period of the Games; organized free lectures about music copyright for professional music creators in the Central Conservatory of Music and other music colleges and provided them with convenient service for joining MCSC, also, as CISAC moved its Asia-pacific office to Beijing from Singapore at beginning of the year, MCSC would join hands with CISAC for building closer contact and cooperation with international organizations and overseas similar societies in future.



Negotiating, lawsuit and cooperation form the necessary process of urging quite a number of industries and businesses reach licensing agreement with MCSC for their legal usage of music. In 2014, MCSC continued to intensify efforts to legal cases against music copyright infringement and made its first lawsuit against broadcasting right in mainland China. Although engaging in lawsuits is against MCSC's will, it is really essential for reinforcing and strengthening our licensing work for broadcasting right. During the period of 2012 and 2013, after rounds of negotiations, MCSC finally signed agreements for royalty payment with the TV Copyright Committee and the Radio Copyright Committee of CRTA (China Radio & Television Association) separately to set up the solution for royalty payment by broadcasting industry. Afterwards, all of central level broadcasters, most of provincial broadcasters and some of municipal broadcasters have reached copyright licensing agreements with MCSC successively. For those broadcasters which always ignore relevant laws and regulations and the industrial solution, MCSC had to take legal action for safeguarding music copyright and maintain fair and orderly copyright market environment.

20 years' working experience of MCSC has proved that the effect of music copyright collective management depend on not only the persistence and devotion of MCSC itself but also the improvement of external environment which include copyright awareness of our whole society, legislation of copyright, judicial redress for copyright infringement and so on. MCSC hope to make the slogan of "To respect music creators' fruits of labor "come to clear awareness of copyright and practical action for safeguarding copyright by litigation.







近几年,协会许可收益成稳步上升态势。2014年许可总金额达到约人民币 1.37 亿元,比较 2013年增长了22.36%。





2014年,协会共完成四期11次版税分配,共计分配金额1.18亿元。具体情况如下:


In 2014, MCSC finished 11 distributions totally, in which the total distributable amount reached about 118 million yuan RMB. The detailed information of the distributions is listed as below:



#### 法务工作

Legal Affairs

2014年,协会法务部直接承办民事诉讼 12件,诉讼支出 14万余元,索赔和追回著作权使用费 1335万余元, 待执行款 4 万余元;发律师函且未进行诉讼的案件共计 8 件,追回著作权使用费 6 万元;待立案案件 8 件,支出 1万余元。法务部指导外地律所代理的诉讼 28件,诉讼支出 12万余元,追回著作权使用费 19万余元,待执行款 30 万余元; 为配合地办工作发函且未进行诉讼的案件共计30件,支出8千余元,追回著作权使用费15万余元; 地办待立案案件38件,支出11万余元。

In 2014, the Legal Affairs Department of MCSC directly undertook 12 civil cases against copyright infringement (the total litigation expenses: 140,000 yuan RMB, damages and royalties awarded by courts: 13.35 million yuan RMB received and 40,000 yuan RMB expected to be paid); sent lawyer's letters to 8 infringers (the royalties of 60,000 yuan RMB was recovered), and 8 cases expected to be put on record in court soon (expenses: 10,000 yuan RMB).

In addition, in 2014 under the guide of the Legal Affairs Department of MCSC, 28 cases were undertaken by local layers (the total litigation expenses: 120,000 yuan RMB, damages and royalties awarded by courts: 190,000 yuan RMB received and 300,000 yuan RMB expected to be paid); the royalties of 150,000 yuan RMB was recovered through sending lawyer's letters against 30 infringements (expenses: 8,000 yuan RMB); 38 cases expected to be put on record in court (expenses: 110,000 yuan RMB).




#### 资料储备

Documentation

截至 2014 年, DIVA 中文作品数据库作品数目达到 610 万余首,其中 CASH(香港音乐著作权协会)登记作 品为 521.4 万余首, MACP(马来西亚音乐著作权协会)作品 35.6 万余首, MÜST(台湾音乐著作权协会)作品 19.4 万余首, 我会登记作品为34.6 万余首(原创作品28.7 万余首,影视作品4.7 万余首,改编作品6千余首,填 词作品 4 千余首), 其中协会申请 ISWC 作品为 11.4 万首。

By the end of 2014, there had been 6.1 million musical works recorded on DIVA system, of which 346,000 works registered by MCSC and 114,000 works applied for ISWC code by MCSC.
