

各位会员:

大家好!

难忘的 2023 年过去了。这一年, 我们摘下了防护口罩, 向彼此露出真挚的微笑;这一年,我们踏上了高铁列车,启程 期盼已久的旅行;这一年,我们走进了音乐厅,走进了演唱会, 和同样热爱音乐的朋友们一起感受现场的节奏与律动。2023 年,协会同样迎来了新的发展阶段,我们以全新的面貌直面挑 战、拥抱机遇。

2023年是协会理事会换届后,全新领导班子掌舵的第一 年。面对三年疫情给各行业带来的冲击,以及大型在线音乐平 台拒不与协会续约,造成协会正常的许可业务出现了巨大规 模的收入缺口,协会管理执行层在中央宣传部、中央社会工作 部和民政部等主管机关的正确指导和有力支持下,坚持守正 创新, 稳中求进, 通过其他类型许可业务的开拓, 顽强地弥补 住了巨大的收入缺口, 并最终成功实现年度许可收入 4.27 亿 元人民币, 较 2022 年度有平稳增长, 这一业绩的取得殊为不 易。其中, 涉及各行业众多商家背景音乐和大量现场演出活动 的表演权许可收入达到 1.13 亿元人民币, 首次破亿元大关, 这 是一个令人振奋的历史性突破。



2023年,协会一步一个脚印,走得稳健、走得踏实。这一年,协会新增会员785人,国内会员总数达12864人(含 团体会员)。这一年,协会向广大会员等国内外音乐著作权人分配使用费 5.41 亿元人民币,达到历年最高水平。

这一年,在服务国家大型活动及重点项目方面,协会为第31届世界大学生夏季运动会("成都大运会")、第十九届 亚洲运动会("杭州亚运会")两大重要国际赛事提供音乐著作权许可服务;继续为中宣部"学习强国"学习平台提供著 作权支持;为第六届中国国际进口博览会("上海进博会")参展者提供音乐著作权法律咨询和一站式音乐作品著作权 许可服务, 六届全勤, 续写进博之约。

2023年,协会还成功举办了一系列宣传活动,为推动我国音乐著作权保护事业的不断进步而发声。为促进著作权 法的有效实施,协会于4月22日举办了"视听作品词曲作者著作权保护国际研讨会",并于4月25日与北京互联网


法院共同举办了"音乐版权司法保护座谈会"。为了增进 版权国际交流,协会于2月22日举办了"第九届中日音 乐著作权研讨会"。为了加强与全球范围同类著作权集体 管理组织的合作,协会于6月8日与中国香港地区音乐 著作权协会 (CASH)、中国澳门地区音乐著作权协会 (MACA) 在深圳共同举办了"第一届粤港澳大湾区音乐 作品著作权集体管理高峰论坛", 并于 11 月 24 日参与 承办了由国家版权局主办的"中非版权合作论坛",与来 自摩洛哥、博茨瓦纳、马拉维、津巴布韦的四家非洲音乐 著作权集体管理组织签署了相互代表协议。

2023年11月19日,我们在北京隆重召开了"中国 音乐著作权协会成立 30 周年暨著作权集体管理制度实

施 30 周年纪念大会"。在这一继往开来的重要历史时 刻, 我们满怀对协会成立 30 年来风雨历程的不尽感慨, 感恩为音乐著作权保护事业开辟道路并奋勇前行的人 们, 感恩党和政府、社会各界、国内外友好人士长期以来 给予协会的关怀和支持。

峥嵘岁月, 风霜铸就。砥砺奋进三十年, 协会初心未 改;未来的路,协会使命依旧。

Dear members.

Hello everyone!

2023 has passed, leaving indelible memories. Throughout the year, we removed our protective masks, revealing sincere smiles to one another. We boarded high-speed trains, embarking on long-awaited journeys. We entered concert halls, attended live performances, and shared the rhythms and melodies with friends who share the same passion for music. In 2023, MCSC also embarked on a new phase of development, confronting challenges and embracing opportunities with a renewed outlook.

In 2023, following the election of a new board of directors, it marked the first year under the helm of a fresh leadership team for MCSC. Confronted with the impacts of a three-year pandemic across various sectors and the refusal of major online music platforms to renew contracts with MCSC, substantial revenue gaps in our normal licensing operations emerged. Under the correct guidance and strong support of supervisory authorities such as the Publicity Department, the Social Work Department, the Ministry of Civil Affairs, and other relevant agencies, MCSC's management and executive team has upheld integrity and embraced innovation while pursuing steady progress. Through the exploration of alternative licensing opportunities, we tenaciously bridged the significant revenue gap, achieving a successful annual licensing income of 427 million RMB, demonstrating steady growth compared to 2022. This achievement was hard-won. Notably, revenue from performing rights licensing, encompassing background music for numerous businesses across various industries and a multitude of live events, surpassed the 100 million RMB mark for the first time, marking a historic and uplifting breakthrough.

In 2023, MCSC made steady and solid progress step by step. We welcomed 785 new members, increasing the total domestic membership to 12,864 (including organizational members). During this year, MCSC distributed royalties totaling 541 million RMB to music rights holders both domestically and internationally, marking the highest distribution level in our history.


During this year, MCSC provided music copyright licensing services for two major international events: the 31st FISU World University Summer Games (Chengdu Universiade) and the 19th Asian Games (Hangzhou Asian Games). We continued to provide copyright support to "Xuexi Qiangguo" initiated by the Publicity Department. Additionally, we offered legal consultations on music copyright and one-stop licensing services for music works to exhibitors of the 6th China International Import Expo (Shanghai Import Expo), maintaining a perfect attendance record over six editions and continuing our commitment to the Import Expo.

In 2023, MCSC also successfully organized a series of publicity activities to promote the continuous progress of music copyright protection in China. In order to promote the effection of the Copyright Law MCSC has

implementation of the Copyright Law, MCSC hosted the "International Symposium on Copyright Protection of Music Creators for Audiovisual Works" on April 22nd, and the "Seminar on Judicial Protection of Music Copyright" in collaboration with the Beijing Internet Court on April 25th. Enhancing international copyright exchanges, MCSC held the 9th China-Japan Music Copyright Seminar on February 22nd. Strengthening collaboration with global collective management organizations, on June 8th, MCSC jointly organized the 1st "Guangdong-Hong Kong-Macao Greater Bay Area Collective Management of Copyright in Musical Works Forum" with Composers and Authors Society of Hong Kong Ltd (CASH) and Macau Association of Composers, Authors and Publishers (MACA) in Shenzhen. Additionally, on November 24th, MCSC co-organized "Forum on Sino-African Copyright Cooperation" hosted by the National Copyright Administration of China, signing reciprocal representation agreements with four African music copyright collective management organizations from Morocco, Botswana, Malawi, and Zimbabwe.



作为协会音乐作品著作权大集成系统(iSMC)的子系统 — DIVA (Documentation — Innovation-Visionary -Art) , 全球最大华语音乐著作权信息大数据系统一直以来是协会管理音乐作品资料所使用的系统。目前,该系统 由中国大陆(MCSC)、中国香港(CASH)、中国台湾(MÜST)、中国澳门(MACA)、马来西亚 (MACP)、印尼(WAMI)、泰国(MCT)7家音乐著作权集体管理协会共同使用。截止2023年底,DIVA数据库 登记作品数目近1882万首。

As a subsystem of MCSC's Integrated System of Music Copyright (iSMC) —DIVA (Documentation - Innovation -Visionary - Art), the world's largest big data system for Chinese music copyright information, has been using by MCSC to manage musical works. Currently, the system is shared by seven music copyright collective management societies, including Mainland China (MCSC), Hong Kong, China (CASH), Taiwan, China (MÜST), Macao, China (MACA), Malaysia (MACP), Indonesia (WAMI) and Thailand (MCT). By the end of 2023, the total of about 18.82 million works were registered on DIVA system.





2013年~ 2023年许可收入 2013~2023 Annual Collections







2023年许可收入构成 2023 Total Revenue Sources

关于使用费分配的相关说明

Explanatory notes for royalty distribution

1. 协会的使用费分配程序遵循国际通行规则和会员大会制定的具体分配规则。

MCSC usually conducts royalty distribution based on common international practices and the Distribution Rules made by MCSC General Assembly.

2. 使用费分配程序必须在收到使用费且确认音乐使用报告后才能启动,二者缺一不可。音乐使用报告一般由音乐使用者提供,包括使用曲目、频次等信息,是确定使用费分给谁、分多少的重要依据。

MCSC distributes royalties depending on royalties plus usage reports. Usage reports are provided by licensees, in which the information include used works, copyright shares, usage frequency, etc.


- 3. 除图书、音像、广告等少数使用情形外,使用者通常是签约当年交费(使用音乐前),次年提交音乐使用报告(使用音乐后)。 Except for books, audio & video products and advertisements, users usually pay royalties in the current year when signing (before using music), and provide with usage reports in the next year (after using music).
- 4. 收到音乐使用报告后,协会需对真实性、准确性进行核查。有疑问的,需要使用者补充甚至重新提供。

After receiving usage reports, MCSC needs to verify the authenticity and accuracy of usage information. For any error or missing information, the users are obligated to supplement or even provide again.

5. 凡向著作权人分配的使用费,在分配完成前产生的相应利息,自始均归著作权人。

All the royalties shall be distributed to copyright owners and the corresponding interest generated before the completion of distribution shall belong to copyright owners all the way.



2023年,协会共办理维权案件146起,其中表演权(背景音乐)案件27起,表演权(现场表演)案件35起,复制权案件2起,信息网络传播权案件38起,广播权案件36起、合同违约8起。

In 2023, MCSC took 146 legal cases in total against copyright infringement, which include 27 BGM cases, 35 live performance cases, 2 mechanical reproduction cases, 38 digital online cases, 36 broadcasting cases and 8 cases against contracting breach.

克服巨大困难 著作权许可收入实现平稳 增长

Overcoming Great Challenges: Achieving Steady Growth in Copyright Licensing Revenue

2023 年,新冠疫情虽然基本结束,但各行各业经过三年 的疫情冲击尚未完全恢复,与疫情前相比,音著协的各项 工作仍面临着严峻的挑战。特别是个别处于商业垄断态势 的超大型在线音乐平台拒不与协会续约,并借助其市场强 势垄断地位持续大规模侵权使用音著协管理的音乐作品, 严重损害了广大音乐作品著作权人的著作权益。为应对这 一严峻挑战, 在协会新一届领导班子的坚强领导下, 音著 协积极采取诉讼、向版权主管机关反应情况等维权措施, 持续进行维权。除此之外,音著协还与相关行业组织、典 型许可使用者积极沟通洽商, 在稳定既有许可关系的同时, 积极拓展各类新的许可业务, 最终成功稳住著作权许可工 作大局, 实现年度许可收入 4.27 亿元人民币 (到账金额), 较 2022 年度的 4.17 亿元收入有平稳增长。在收入缺口 高达上亿元的不利影响下,协会不畏艰难,通过其他类型 业务的开拓,终于顽强地弥补住上述巨大的收入缺口,并 最终成功实现了许可收入的增长,殊为不易。

In 2023, although the COVID-19 pandemic has essentially ended, various industries have not fully recovered from the impact of the past three years. Compared to the pre-pandemic period, MCSC still faces severe challenges in its operations. Notably, certain mega online music platforms with monopolistic tendencies have refused to renew their con-

tracts with MCSC. Leveraging their dominant market positions, these platforms have continued to infringe on a large scale, using music works managed by MCSC without authorization, thereby seriously harming the copyright interests of numerous music creators.

To address this serious challenge, under the strong leadership of the new executive team, MCSC has actively pursued litigation and reported the situation to the copyright authorities, continuously defending its rights. In addition, MCSC has engaged in proactive communication and negotiations with relevant industry organizations and typical licensees. While stabilizing existing licensing relationships, it has actively expanded various new licensing businesses. Ultimately, MCSC successfully maintained the overall stability of its copyright licensing efforts, achieving an annual licensing revenue of 427 million RMB (amount received), a steady increase compared to the 417 million RMB in 2022.

Despite facing a significant revenue gap exceeding 100 million RMB, MCSC remained undaunted by difficulties and managed to bridge this substantial shortfall through the development of other types of businesses. This resilient effort ultimately led to the successful growth in licensing revenue, an achievement that is truly commendable.

商家背景音乐和现场表演的表演权许可 收入首次突破 1 亿元人民币

Revenue from Performing Rights Licensing for Background Music in Commercial Establishments and Live Performances Exceeded 100 Million RMB for the First Time

2023 年,音著协表演权业务(含背景音乐和现场表演)许可收费额已达 1.13 亿元人民币,首次实现破亿,涉及酒店、餐饮、商场、超市、酒吧、专卖店、健身、展馆、主题公园、航空、候车室、航站楼、音乐喷泉、办公大楼等众多行业十万多家门店的背景音乐播放,以及数千场现场演出。上述表演权许可业务收入从初期的年收入几十万元到今年的过亿元,是一个历史性的突破。这些不仅仅是收入数据的变化,更是体现了我国著作权集体管理制度的有效普及、音乐文化市场的繁荣以及音乐版权保护日益强化。

In 2023, the revenue from performing rights licensing (including background music and live performances) of MCSC had reached 113 million RMB, surpassing the 100 million RMB milestone for the first time. This licensing revenue encompasses the use of background music in over 100,000 establishments across various industries, such as hotels, restaurants, shopping malls, supermarkets, bars, specialty stores, fitness centers, exhibition halls, theme parks, airlines, waiting rooms, terminals, musical fountains, and office buildings, as well as thousands of live performances. This historic breakthrough, from an initial annual income of several hundred thousand RMB to over 100 million RMB this year, signifies not just a change in revenue figures but also reflects the effective popularization of China's collective copyright management system, the prosperity of the music culture market, and the strengthening of music copyright protection.

Live Performance Licensing Revenue Achieved Significant Growth

演类许可 1300 余份,其中涉及的现场表演类活动例如张 学友演唱会、华晨宇演唱会、黄绮珊演唱会、天空之城动 漫音乐会、深圳草莓音乐节、雅诗兰黛快闪活动、海南国 际电影节等。

The revenue from live performance licensing reached 37.37 million RMB, representing a 496% increase compared to the live performance licensing revenue in 2022. A total of over 1,300 live performance licenses were issued, covering events such as Jacky Cheung's concert, Hua Chenyu's concert, Huang Qishan's concert, the Castle in the Sky anime concert, the Shenzhen Strawberry Music Festival, Estée Lauder pop-up events, and the Hainan International Film Festival.

The Highest Distribution Amount in History

2023 年音著协的许可使用费分配工作有条不紊地顺利完成,全年四期 13 次共涉及许可使用费金额 5.41 亿元人民币 (扣除增值税 6% 后为 5.1 亿元人民币),年度分配总金额为历年最高,将词曲作者等音乐作品著作权人的合法权益落到了实处。

In 2023, MCSC successfully and methodically completed the distribution of licensing fees. Over the course of the year, 13 distributions were made across four phases, involving a total of 541 million RMB in licensing fees (510 million RMB after deducting 6% VAT). This annual distribution amount is the highest in history, effectively safeguarding the legitimate rights and interests of lyricists, composers, and other music copyright holders.

会员总数保持稳定增长

Steady Growth in Total Membership

2023 年,音著协新发展会员 785 人,继续保持了稳定增长的势头,截至 2023 年年底,会员总数达 12864 人。新发展的会员例如:北京好乐无荒文化有限公司、北京酷音天籁音乐有限公司、广州索氧音乐文化传播有限公司、广东一窝蜂文化科技有限公司、沈阳星巢骁盛文化传媒有限公司、都智文、雨宗林、十三狼、李仁赫、廖建中、陈卫东、金旭庚、尹约、张靓、刘兆伦、陈禹、洪川、隋晓峰、苑飞雪、祁峰、廖羽、萨吉、胡继沿等。

In 2023, MCSC welcomed 785 new members, continuing a trend of steady growth. By the end of 2023, the total membership reached 12,864. New members include companies such as Beijing HL Entertainment, Beijing Quiet Line Music, Guangzhou SOYOUNG Music, Guangdong Yiwofeng culture and technology Co., Shenyang Xingchaoxiaosheng Culture Media Co, as well as individuals like Du Zhiwen, Yu Zonglin, Shisanlang, Li Renhe, Liao Jianzhong, Chen Weidong, Jin Xugeng, Yin Yue, Zhang Liang, Liu Zhaolun, Chen Yu, Hong Chuan, Sui Xiaofeng, Yuan Feixue, Qifeng, Liao Yu, Sa Ji, Hu Jiyan, etc.

为成都大运会、杭州亚运会提供音乐著 作权支持

Providing Music Copyright Support for the Chengdu Universiade and the Hangzhou Asian Games

2023 年音著协为第 31 届世界大学生夏季运动会("成都大运会")、第十九届亚洲运动会("杭州亚运会")提供音乐著作权许可服务。音著协作为音乐著作权集体管理组织,借助著作权集体管理制度优势,能够向活动组织方提供音乐作品一揽子许可方案,化解活动中使用音乐作品的著作权法律风险,为活动的成功举办保驾护航。

In 2023, MCSC provided music copyright licensing services for the 31st FISU World University Summer Games ("Chengdu Universiade") and the 19th Asian Games ("Hangzhou Asian Games"). As a collective management organization of music copyrights, MCSC, with the advantages of the copyright collective management system, is able to provide event organizers with music work blanket licensing to resolve the legal risks of the use of music works during the events, and help to ensure the success of the events.

Continue to Provide Music Copyright Support for the "Xuexi Qiangguo" Learning Platform

2023 年,音著协继续为中共中央宣传部"学习强国"学习平台提供音乐著作权支持。自"学习强国"学习平台于2019 年初在全国上线以来,音著协连续 5 年担任"学习强国"学习平台音乐著作权服务单位。

In 2023, MCSC continued to provide music copyright support for the "Xuexi Qiangguo" learning platform of the Publicity Department of the CPC Central Committee. Since the platform's nationwide launch in early 2019, MCSC has been the music copyright service provider for "Xuexi Qiangguo" for five consecutive years.

Six Consecutive Editions! Continuing the "CHE Commitment"

2023年11月5日,第六届中国国际进口博览会("进博会") 如约而至,音著协六届全勤为参展者提供音乐著作权法律咨询和全渠道、全流程、一站式的音乐作品著作权许可服务。音著协作为进博会服务中心连续六年的"全勤"参与者,通过开展展会音乐版权服务的一系列实践,构成进博会知识产权服务体系中的重要一环,携手展会组织者共同为推动我国知识产权保护事业的创新发展贡献力量。

On November 5, 2023, the sixth China International Import Expo (CIIE) commenced as scheduled. MCSC has consistently participated in all six

editions, providing exhibitors with legal consultations on music copyright as well as comprehensive, full-process, one-stop music copyright licensing services. As a continuous participant in the CIIE Service Center for six years, MCSC has become a crucial part of the CIIE's intellectual property service system through its extensive practice in music copyright services, and together with the event organizers, MCSC contributes to the innovative development of intellectual property protection in China.

Expanding Licensing Business to the Cruise Industry

邮轮行业作为国内新兴行业,发展潜力巨大。自 2021 年实 现邮轮行业签约零的突破以来, 音著协继续通过多方调查 研究, 针对邮轮行业制定了专属的音乐著作权许可方案, 2023年成功与更多邮轮经营方建立音乐著作权许可合作。

As a burgeoning industry in China, the cruise sector has enormous development potential. Since achieving a groundbreaking first agreement in the cruise industry in 2021, MCSC has continued to conduct extensive research and investigations. In response, MCSC has developed specialized music copyright licensing solutions tailored to the cruise industry. In 2023, MCSC successfully established music copyright licensing partnerships with more cruise oper-

Baidu's "Xiaodu" Smart Speaker Found Liable for Music Copyright Infringement and Was Ordered to Pay Damages

2023 年 1 月, 北京互联网法院就音著协起诉北京百度网 讯科技有限公司智能音箱系列侵犯音乐著作权案件的其中 四案作出一审判决:被告北京百度网讯科技有限公司就涉 案歌曲使用承担侵权责任,并赔偿音著协相关经济损失及 合理支出共计约8700元人民币。

In January 2023, the Beijing Internet Court issued first-instance judgments in four cases where the Music Copyright Society of China (MCSC) sued Beijing Baidu Netcom Science and Technology Co., Ltd.

for music copyright infringement involving its smart speaker series. The court ruled that the defendant, Beijing Baidu Netcom Science and Technology Co., Ltd., was liable for the unauthorized use of the songs involved in the cases and ordered the company to compensate MCSC for related economic losses and reasonable expenses, totaling approximately 8,700 RMB.

音著协代表久石让维权 北京爱乐经典管弦 乐团被判侵权

MCSC Representing Joe Hisaishi in a Copyright Infringement Case: Beijing Philharmonic Classic Orchestra Found Liable

2023年7月, 音著协收到北京市西城区人民法院送达的一 审判决书。在判决书中,法院认定被告北京爱乐经典管弦 乐团未经许可使用他人音乐作品演出的行为构成侵权, 应 当停止侵权行为并向音著协赔偿经济损失及合理支出共计 约 37000 元人民币。

In July 2023, MCSC received a first-instance judgment from the Beijing Xicheng District People's Court. The court determined that the defendant, Beijing Philharmonic Classic Orchestra, had infringed upon music copyrights by performing other individuals' musical works without permission. The court ordered the orchestra to cease the infringing activities and compensate MCSC for economic losses and reasonable expenses, totaling approximately 37,000 RMB.

腾讯音乐 (TME) 旗下酷我音乐和酷狗音乐 一审均被判侵权使用音乐作品

TME's Kuwo and Kugou Music Found Liable for Copyright Infringement in **First-Instance Judgments**

2023 年 12 月, 北京互联网法院一审判决腾讯音乐娱乐集 团 (TME) 旗下的北京酷我科技有限公司 ("酷我音乐") 侵害了音著协管理的涉案音乐作品的著作权,并判令酷我 音乐向音著协支付赔偿金约 3.3 万元人民币。2023 年 12 月 21 日,广州互联网法院就音著协起诉腾讯音乐娱乐集团 (TME) 旗下的广州酷狗计算机科技有限公司("酷狗音乐") 侵权使用音著协管理的 41 首歌曲的十个案子做出一审判 决, 判决酷狗音乐侵害音著协对案涉歌曲享有的信息网络 传播权,应向音著协支付赔偿金约15万元人民币,并在酷 狗音乐平台上删除涉案侵权音乐作品的全部版本。

In December 2023, the Beijing Internet Court issued a first-instance judgment ruling that Tencent Music Entertainment Group (TME)'s Beijing Kuwo Technology Co., Ltd. ("Kuwo Music") had infringed upon the copyrights of music works managed by the MCSC and ordered Kuwo Music to pay approximately 33,000 RMB in damages to MCSC. On December 21, 2023, the Guangzhou Internet Court issued a first-instance judgment in ten cases brought by MCSC against Tencent Music Entertainment Group (TME)'s Guangzhou Kugou Computer Technology Co., Ltd. ("Kugou Music") for infringing the right of communication through information network of 41 songs managed by MCSC. The court ordered Kugou Music to pay approximately 150,000 RMB in damages to MCSC and to remove all versions of the infringing music works from the Kugou Music plat-

The participants engaged in in-depth discussions on issues related to copyright protection for lyricists and composers of audiovisual works. The symposium provided professional insights and ideas for the protection of lyricists' and composers' rights in audiovisual works in China, as well as for the improvement and revision of the supporting regulations of the Copyright Law.

Seminar on Judicial Protection of Music Copyright

On April 25, 2023, MCSC and the Beijing Internet Court jointly hosted the "Seminar on Judicial Protection of Music Copyright." This seminar was part of the 4.26 Intellectual Property Week activities and also a judicial research initiative by the Beijing Internet Court in response to the call from the Central Committee of the Communist Party of China to promote extensive investigation and research within the Party. More than 20 judges from the Beijing Internet Court, Professor Guo Xiaohu, a doctoral supervisor in composition at the Central Conservatory of Music, and Professor Yang Nailin, a master's supervisor in opera composition at the Central Conservatory of Music, along with other lyricists and composers, attended the seminar.

助力《粤港澳大湾区发展规划纲要》发展目标的实现,音 著协与中国香港地区音乐著作权协会(CASH)和中国澳 门地区音乐著作权协会(MACA)在深圳共同举办了"第 一届粤港澳大湾区音乐作品著作权集体管理高峰论坛", 中宣部版权管理局局长王志成、中联办(香港)宣传文体 部副部长张国义、中联办(澳门)宣传文化部处长白冰、 香港知识产权署署长黄福来等政府部门,以及国际组织代 表、知名音乐家、法官、高校专家、行业协会代表等 100 多位嘉宾现场出席了本次活动。

此次高峰论坛的成功举办,使内地、香港和澳门三地音乐 作品著作权集体管理组织之间的合作更加紧密, 其后续产 生的社会影响将辐射到粤港澳大湾区的文化产业之中。

On June 8, 2023, in order to implement the spirit of the "Outline for Building a Powerful Country with Intellectual Property Rights (2021-2035)" and the "14th Five-Year Plan for Copyright Work", and to help realize the development goals of the "Outline Development Plan for the Guangdong-Hong Kong-Macao Greater Bay Area", MCSC, together with the Composers and Authors Society of Hong Kong Ltd (CASH) and the Macau Association of Composers, Authors and Publishers (MACA) co-organized the first "Guangdong-Hong Kong-Macao Greater Bay Area Collective Management of Copyright in Musical Works Forum" in Shenzhen. The event was attended by over 100 guests, including Wang Zhicheng, Director of the National Copyright Administration under the Publicity Department of the CPC Central Committee, Zhang Guoyi, Deputy Director of the Department of Publicity, Culture, and Sports of the Liaison Office of the Central People's Government in the Hong Kong S.A.R., Bai Bing, Director of the Department of Publicity and Culture of the Liaison Office of the Central People's Government in the Macao S.A.R., and Huang Fulai, Director of the Intellectual Property Department of Hong Kong S.A.R., as well as representatives of international organizations, renowned musicians, judges, university experts, and industry association representatives.

In November 2023, at the Forum on Sino-African Copyright Cooperation of the 9th China International Copyright Expo, MCSC signed mutual representation agreements with four African music copyright collective management organizations from Morocco, Botswana, Malawi, and Zimbabwe, expanding the scope and content of China-Africa copyright

cooperation.

During the 9th China International Copyright Expo, MCSC, together with the Asia-Pacific region of the International Confederation of Societies of Authors and Composers (CISAC), co-hosted a training session for African copyright collective management organizations. Organizations from nine African countries, including Zimbabwe, Morocco, Uganda, Côte d'Ivoire, Botswana, Burkina Faso, Benin, Senegal, and Malawi, participated in the training.


中国音乐著作权协会成立以来的 30 年, 是协会为音乐著 作权人、音乐使用者不断提供更高水平版权服务的 30 年, 是我国著作权集体管理制度从无到有并逐渐发展完善的 30 年, 也是我国大力推动《著作权法》立法完善和深入 实践的 30年。此次活动具有重要的宣传作用和社会意义: 一是可以纪念和致敬 30 年来大力支持我国音乐著作权集 体管理事业并做出突出贡献的人物;二是可以彰显我国著 作权法的实施水平和著作权集体管理制度的社会价值,以 及中国政府参与并支持国际版权合作和对话的态度、决心 和成绩; 三是可以凝聚社会共识与全球力量, 更好地推动 我国著作权集体管理事业乃至版权强国、文化强国建设。

On November 19, 2023, MCSC held the "Ceremony Marking the 30th Anniversary of the Music Copyright Society of China and the 30th Anniversary of the Copyright Collective Management System" in Beijing. Gadi Oron, Director General of CISAC; Wang Zhicheng, Director of the National Copyright

Administration under the Publicity Department of the CPC Central Committee; and Lei Lei, Chairman of MCSC and renowned composer, attended the ceremony. More than 300 representatives from domestic government departments, judicial authorities, social organizations, music creators, music publishers, music users from various industries, and copyright collective management organizations from both China and abroad attended the ceremony.

The 30 years since the founding of MCSC have been a period in which MCSC has provided music copyright holders and users with a higher level of copyright services, in which China's copyright collective management system has been developed and perfected from scratch, and in which China has vigorously promoted the improvement of the legislation

of the Copyright Law and its in-depth practice. This event holds significant promotional and social value: firstly, it serves to commemorate and honor those who have significantly contributed to the development of music copyright collective management in China over the past 30 years; secondly, it highlights the implementation level of China's Copyright Law, the social value of the copyright collective management system, and the Chinese government's commitment to and achievements in international copyright cooperation and dialogue; thirdly, it aims to build social consensus and global support to better advance China's copyright collective management and contribute to the development of building a powerful intellectual property nation and cultural power.
